STATEMENT OF OFFENSE:

<u>Background</u>: Around the end of February 2002, an acquaintance of the defendant brought him home to stay after the defendant was asked to leave his mother's residence. The acquaintance was the husband of one of two sisters and a cousin who lived in the same neighborhood. For about one month, the defendant stayed at all three womens' homes and had contact with their sons, the minor victims. The five victims range in age from nine to eleven years old.

Offense: The mother of one of the victims noted a burn mark on her son on March 29, 2002. When she asked him about the mark, he made allegations of sexual molestation by the defendant, so she called the Pima County Sheriff's Department (PCSD). Later that evening, forensic interviews were conducted with all five victims.

own penis. John Said he saw the defendant masturbate himself to the point of ejaculation, and he showed him magazines depicting naked, adult females. Come was anally penetrated by the defendant on March 27, 2002, as was his twin, Come Arms. Come also was shown adult pornography, and, while the defendant showed him these images, he masturbated his own penis to the point of ejaculation. Come Arms reported that, on March 27, 2002, the defendant performed oral sex on his younger brother, Doma Arms, and had Doma perform oral sex on him. Doma Armsalso recalled the defendant had him perform mutual masturbation on March 27, 2002.
